

HQUSACE and MSCs continue to gather data to optimize the use of **recently dropped BUILDING FY23 funding** for electric vehicle supply equipment (EVSE) installation. This month's **STRONG®** newsletter provides MSCs with information on Division-level EVSE Strategic Plans and guidance on how to implement them.

FY23 FUNDING DROP

**FY23
FUNDING
IS HERE!**

Thank you for your patience while the FY23 funding was sorted and prioritized! Earlier this month, HQUSACE released the anticipated FY23 funds to MSCs in support of FY23 EVSE planning and implementation. The available funding continues to apply only to sites funded by Civil Works Operation & Maintenance (CW O&M), but HQUSACE is working to find funding alternatives for other sites. Below is a summary of our initial roll-out of funds for MSC site assessments:

Of the \$20M in funding for CW O&M USACE sites in FY23, \$1.3M is for site assessment and review only. The remaining \$18.7M will be distributed for equipment purchase and installation, pending review of site assessment data.

HQ is prioritizing the development of guidance on completing site assessments and will distribute it as soon as available.

MSC STRATEGIC PLANS

Kudos to MSCs for submitting their EVSE strategic plans for CW O&M sites. The June newsletter will include a deeper analysis into the plans' trends and lessons learned, but see below for initial highlights:

LRD: Identified how many sites will install EVSE each FY to meet FY27 goals, and if EVSE will be funded by the MATOC or District-Overseen GSA BPA and IDIQs.

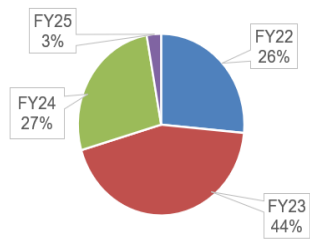
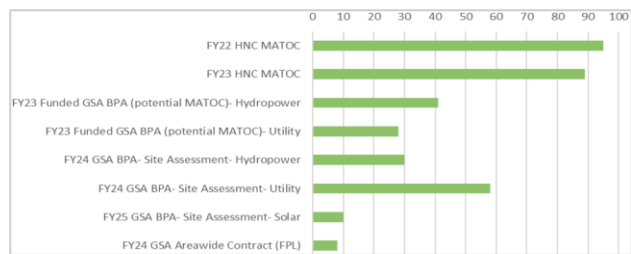
MVD: Outlined quantity and EVSE type per facility and USACE-leased vehicle count.

NAD: Identified 126 O&M GSA-leased vehicles across 42 CW O&M facilities and outlined the acquisition strategy for priority vehicles.

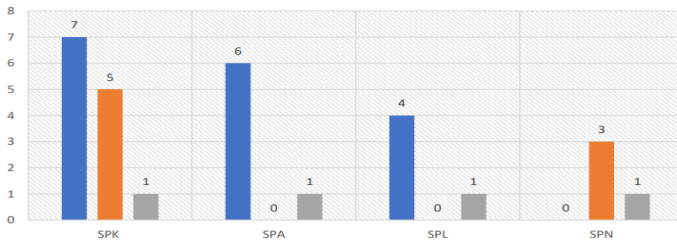
MVP	*Assessments for charging stations to be conducted at Pokegama Dam and Lake Traverse. *Assess Cross Lake, Gull Lake and Lock #6. Cross Lake is constructing a new maintenance building in July to include an electrical setup conducive to support a 4-port EVCS.
MVR	*MRPO, ILLWW Project Office, Coralville, Saylorville Lake and Red Rock would be assessed via BPA to be included on the HNC MATOC. *MRPO, ILLWW Project Office, Coralville and Red Rock charging stations installed (MATOC).
MVS	*Lake Carlyle is currently in the construction phase for EVSE stations. *Lake Shelbyville and Rend Lake are requested to be prioritized for EVSE assessment/installation through the MATOC/BPA
MVM	Caruthersville Area Office and Wynne Area Office would be site assessed with HQ central funds via BPA to be included on the HNC MATOC.
MVK	*Monroe Navigation Project Office, Lake Ouachita, DeGray Lake would be assessed via BPA to be included on the HNC MATOC. *Monroe Navigation Project Office charging stations installed (MATOC).
MVN	No charging stations will be installed.
