Andrea Carson, a Pittsburgh native, is an Oak Ridge Institute for Science and Education (ORISE) Fellow, at the Conflict Resolution and Public Participation Center of Expertise, Institute for Water Resources, U.S. Army Corps of Engineers. Andrea focuses on teaching about and providing support for collaborative processes between the Corps and its partners. Types of support Andrea provides includes: trainings for USACE and other agency representatives on conflict management, facilitation, and communication skills; support for staff in the field on the creation and implementation of public involvement plans; and facilitation for USACE initiatives such as Environmental Flow Assessment (EFA) Workshops, Watershed Informed Budgeting Workshops, and Multi-Hazard Tournaments. Prior to working at USACE, Andrea taught courses on natural resources negotiation and decision-making and provided facilitation services for small community water management issues. Andrea received a M.S. in Water Resources Policy and Management and a Certificate in Water Conflict Management and Transformation from Oregon State University and a B.S. in Environmental Studies and Globalization Studies from Gettysburg College.
