SUBJECT: Handshake Partnership Program – Fiscal Year 2016 Recipients

1. I am pleased to announce the recipients for the fiscal year 2016 (FY 2016) Handshake Partnership Program funding (see enclosure). These outstanding partnership endeavors demonstrate the efforts of our field projects to work with our stakeholders and foster their involvement in improving and protecting our parks and natural resources. This initiative supports the U.S. Army Corps of Engineers' efforts in being a community partner and working on grass roots projects.

2. The enclosed list identifies the FY 2016 recipients. These examples of engagement show that our partnering programs are an invaluable tool in getting communities involved outdoors and accomplishing worthwhile projects that benefit our parks and our visitors. I wish these partnering efforts the greatest success.

3. We are proud to have a pool of recipients that are diverse in both geographic area and in project ideas. In FY 2016, we are funding 16 projects that span 11 Corps districts within six divisions. We also continue to have a variety of partnership project ideas which include:

- Shoreline erosion repairs and rehabilitation
- Water and land based trail projects
- Fisheries habitat improvements and pond repairs
- Interpretation and education projects in both indoor and outdoor settings
- · American chestnut research and nursery planting
- An archery park
- Improvements to an existing off road vehicle park
- And an astounding number of opportunities for partners to be involved in our parks

4. This year's funded projects involve 111 partners who have pledged more than \$750,000, (64%) of the \$1.18 million to be invested in these worthwhile projects. There are 9 first time recipients and 7 projects where the partner is funding more than 70% of the total project cost. In addition to the monetary benefits, these partnerships are also investing in our communities outdoor activities and getting people into parks. Collectively they will be improving recreational opportunities and facilities for all visitors,
