SUBJECT: Revised Natural Resources Management Uniform Program Allowance Schedule

- 2. This memorandum revises the Natural Resources Management (NRM) Uniform Program Allowance Schedule and is applicable to park rangers and other NRM specialist and managers who are required to wear the NRM uniform in accordance with references 1b and 1c above.
- 3. The revised allowance schedule is attached and is effective for the FY21 uniform program. The uniform supply contractor will adjust the allowance amounts for all currently authorized employees to be effective upon the opening of the FY21 uniform ordering site. References 1b and 1c are being revised to include, among other changes, an updated Table 4, "Class B/C/D Uniform Allowances".
- 4. The U.S. Army Corps of Engineers (Corps) has not increased the allowance schedule for nearly 20 years while the inflation rate under the uniform supply contracts have averaged over a 50% increase per item. This action is necessary to meet agency policy that requires NRM employees to be properly clothed for outdoor environments and public interaction, and for employee safety in being appropriately recognized as an official for the Corps.
