

EKiP Pass

How does this work?

1. The student must present a valid Every Kid in a Park paper voucher.



Retain only this paper voucher.

How does this work? (cont.)

- Issue the pass to the student. Have the student print their name on the back of the card.



- Explain the benefits of the pass, how long it is valid (exp. Sept 2015 to Aug 2016) and that the pass holder must be present to use the pass.
- Write the issued EKIP pass number on the paper voucher.

- Passes are accountable property.
- Numbers must be accounted for.
- All passes issued must be documented.



Below is the procedure that must be followed by all sites that issue the EKiP passes:



1. Paper Voucher has two sections. It is designed so that one copy can be retained with shift documentation, and the other used to enter into the EKiP Voucher Redemption website (if not entered at the time of remittance).
2. Within two weeks of issuing the EKiP pass you **MUST** go to the EKiP Voucher Redemption website and enter the voucher number.
