# CHALLENGE PARTNERSHIP AGREEMENT BETWEEN THE DEPARTMENT OF THE ARMY

THIS AGREEMENT, entered into this day of March 16, 2022, by and between the Department of the Army (hereinafter the "Government"), represented by Kelly C. Finch, Chief of Operations, U.S. Army Corps of Engineers, Huntington District, the Muskingum Watershed Conservation District, (hereinafter "Partner"), represented by Craig W. Butler, American Electric Power, (hereinafter "Partner"), represented by Keith Schalmo, the Buckeye Trail Association (hereinafter "Partner") represented by Steve Walker, Canton Audubon Society (hereinafter "Partner") represented by Richard Basnett, the North Country Trail Association (hereinafter "Partner") represented by Ken Hendrickson, Shenandoah School (hereinafter "Partner") represented by Chad Miller, Ohio Prairie Nursery (hereinafter "Partner") represented by Dave Riddell, Ohio Blue Bird Society (hereinafter "Partner") represented by Darlene Sillick.

WITNESSETH, THAT:

WHEREAS, the Government manages lands and waters at Clendening Lake Dam which includes recreational opportunities for the public, and

WHEREAS, the development and installation of a Wetland Loop Trail and Wildlife Viewing Area at Clendening Public Use Area will increase the recreational opportunities for the public, and

WHEREAS the Partners are interested in promoting and assisting the Government in providing this Wetland Loop Trail and Wildlife Viewing Area, and

WHEREAS, it is mutually beneficial to the Government and the Partners to work cooperatively to make this trail and viewing area available to the public, and

WHEREAS, the Partners, in order to assist the Government in this project has voluntarily agreed to provide volunteer labor, materials and services, and

WHEREAS, Section 225 of the Water Resources Development Act of 1992, PL 102-580, (Oct 31, 1992), authorizes the Secretary of the Army to accept contributions from the Partners and apply those contributions to the Project, and

WHEREAS, 16 U.S.C. Section 460d authorizes the Chief of Engineers to permit the construction of facilities at water resource development projects, and

WHEREAS, the Government and the Partners have the full authority and capability to perform as hereinafter set forth and intend to cooperate in financing and challenge cost-sharing in accordance with the terms of this agreement,

NOW THEREFORE, the Government and the Partners agree as follows:

# ARTICLE I - DEFINITIONS AND GENERAL PROVISIONS

For purposes of this agreement:

- a. The term "Project" shall mean construction, development and maintenance of a one to one and a half mile Wetland Loop Trial featuring two aluminum framed, wood floating boardwalks, concrete wildlife observation platform with scopes, interpretive signs, improvements to pollinator/wildlife habitat, and nesting structures leading from the parking lot to a variety of areas in the Clendening Public Use Area at Clendening Lake Dam.
- b. The term "total project costs" shall mean all costs incurred by the Government and the Partner directly related to construction and completion of the project.
- c. This agreement in no way restricts the Government from participating in similar activities or arrangements with, or accepting contributions from, other public and private agencies, organizations, and individuals.
- d. All donated property, facilities and improvements placed on Government land as well as any work accomplished under this agreement shall become the property of the Government.

# ARTICLE II - OBLIGATIONS OF THE PARTIES

- a. The Government, subject to and using funds appropriated by the Congress of the United States (hereinafter the "Congress"), and using funds provided by the Partners, shall expeditiously construct the Project, applying those procedures usually applied to Federal projects, pursuant to Federal laws, regulations, and policies. The award of contracts, modifications or change orders, and performance of all work on the Project (whether the work is performed under contract or by the Government personnel) shall be exclusively within the control of the Government.
- b. The Government shall provide personnel labor to coordinate project's planning and execution with partners. Personnel labor to track COE labor hours, materials cost and partner cost associated with project. Materials, equipment, and labor for construction of Project.
  - c. The Partners shall provide:

Muskingum Watershed Conservancy District (MWCD)

- Floating boardwalks for trail over wetland.
- Volunteer labor and expertise to install boardwalks

# American Electric Power (AEP)

- Volunteer labor, materials, supplies and use of equipment for installation of Osprey tower

# Buckeye Trail Association (BTA)

- Volunteer labor and expertise for construction of Project

## Canton Audubon

- Volunteer labor and expertise for construction of Project

# Young Men's Christian Association (YMCA)

- Volunteer labor for construction of Project

# North Country Trail Association (NCTA)

- Volunteer labor for construction of Project

## Shenandoah School

- Volunteer labor for construction of project
- Volunteer labor for planning future programs/events for local children.

## Ohio Prairie Nursery (OPN)

- Materials and expertise for seeding pollinator habitat

# Ohio Blue Bird Society (OBBS)

- Volunteer expertise, as well as materials and supplies for nesting structures

- d. The Government shall perform a final accounting to determine the contributions provided by all parties to this agreement and to determine whether each has met its obligations under paragraphs b and c of this Article.
- e. No Federal funds may be used to meet the Partner's total project costs under this Agreement.

# ARTICLE III - METHOD OF PAYMENT

- a. The Government shall maintain current records of contributions provided by the Partners and a current projection of total project costs. At least quarterly, the Government shall provide the Partners with a report setting forth all contributions provided to date and the current projection of total project costs, of the components of total project costs, of each party's share of total project costs, and of the Partner's contribution required in accordance with Article II.b. of this Agreement. On the effective date of this Agreement, total project costs are projected to be \$57,611, and the Partner's contribution required under Article II.b. of this Agreement is projected to be \$21,611. Such amounts are estimates subject to adjustment and are not to be construed as the total financial responsibilities of the Government and the Partners.
- b. The Partners shall provide the contribution required under Article II.b. of this Agreement in accordance with the following provisions: Partner contributions are the sum value of in-kind work, materials, supplies and equipment use equivalent to the worksheet below. Money will not be required in advance of any construction completed. In the event the Government determines that the Partner must provide additional "contributions" to meet its obligation, the Government shall notify the Partner of the additional resources required.
- c. Upon completion of the Project and resolution of all relevant claims and appeals, the Government shall conduct a final accounting and furnish the Partners with the results of the final accounting. The final accounting shall establish total project costs, each party's contribution provided thereto, and each party's required share thereof.
- 1. In the event the final accounting shows that the total contribution provided by the Partners is less than their required shares of total project costs, the Partners shall, no later than 90 calendar days after receipt of written notice, make a payment to the Government of whatever sum is required to meet the Partner's required share of total project costs.
- 2. In the event the final accounting shows that the total contribution provided by the Partners exceed their required share of total project costs, the Government shall, subject to the availability of funds, refund the excess to the Partners no later than 90 calendar days after the final accounting is complete. In the event existing funds are not available to refund the excess to the Partner, the Government shall seek such appropriations as are necessary to make the refund.

## ARTICLE IV - DISPUTE RESOLUTION

As a condition precedent to a party bringing any suit for breach of this Agreement, that

party must first notify the other party in writing of the nature of the purported breach and seek in good faith to resolve the dispute through negotiation. If the parties cannot resolve the dispute through negotiation, they may agree to a mutually acceptable method of non-binding alternative dispute resolution with a qualified third party acceptable to both parties. The parties shall each pay 50 percent of any costs for the services provided by such a third party as such costs are incurred. The existence of a dispute shall not excuse the parties from performance pursuant to this Agreement.

## ARTICLE V - FEDERAL AND STATE LAWS

In exercise of their respective rights and obligations under this Agreement, the Government and the Partners agree to comply with all applicable Federal and State laws and regulations, including, but not limited to, Section 601 of Title VI of the Civil Rights Act of 1964, PL 88-352, and the Department of Defense Directive 5500.11 issued pursuant thereto and published in Part 300 of Title 32, Code of Federal Regulations, as well as Army Regulations 600.7, entitled "Non-discrimination on the Basis of Handicap in Programs and Activities Assisted or Conducted by the Department of the Army."

#### ARTICLE VI - RELATIONSHIP OF PARTIES

- a. In the exercise of their respective rights and obligations under this Agreement, the Government and the Partners each act in an independent capacity, and neither is to be considered the officer, agent, or employee of the other.
- b. In the exercise of its rights and obligations under this Agreement, neither party shall provide, without the consent of the other party, any contractor with a release that waives or purports to waive any rights such other party may have to seek relief or redress against such contractor either pursuant to any cause of action that such other party may have or for violation of any law.

#### ARTICLE VII - OFFICIALS NOT TO BENEFIT

No member of or delegate to the Congress, or resident commissioner, shall be admitted to any share or part of this Agreement, or to any benefit that may arise therefrom.

#### ARTICLE VIII - INDEMNIFICATION

The Partners shall hold and save the Government free from all damages arising from services it performs or provides for the construction, operation, maintenance, repair, replacement, and rehabilitation of the Project, except for damages due to the fault or negligence of the Government or its contractors.

#### ARTICLE IX - TERMINATION OR SUSPENSION

- a. If at any time a Partner fails to fulfill its obligations under this Agreement, the District Commander shall terminate this Agreement or suspend future performance under this Agreement unless he/she determines that continuation of work on the Project is in the interest of the United States or is necessary in order to satisfy agreements with any other non-Federal interests in connection with the Project.
- b. If the Government fails to receive annual appropriations in amounts sufficient to meet Project expenditures for the then-current or upcoming fiscal year, the Government shall so notify the Partners, and 60 calendar days thereafter any party may elect without penalty to terminate this Agreement or to suspend future performance under this Agreement. In the event that a party elects to suspend future performance under this Agreement pursuant to this paragraph, such suspension shall remain in effect until such time as the Government receives sufficient appropriations or until either the Government or the Partner elects to terminate this Agreement.
- c. In the event that a party elects to terminate this Agreement pursuant to this Article, the parties shall conclude their activities relating to the Project and proceed to a final accounting in accordance with Article II of this Agreement.
- d. Any termination of this Agreement or suspension of future performance under this Agreement in accordance with this Article shall not relieve the parties of liability for any obligation previously incurred.

# **ARTICLE X - NOTICES**

a. Any notice, request, demand, or other communication required or permitted to be given under this Agreement shall be deemed to have been duly given if in writing and delivered personally or by telegram, or mailed either by first-class, registered, or certified mail, as follows:

# **Explanations:**

Partner 1: Muskingum Watershed Conservancy District (MWCD) has agreed to donate up to 7 20-foot sections of floating boardwalk and assist with the project. The floating boardwalks are estimated to be worth approximately \$6,000 and their assistance with the project would be during their regular MWCD work hours.

Partner 2: American Electric Power (AEP) has agreed to donate a 50-foot utility pole, attach an Osprey platform, and install the utility pole. The pole is estimated to be worth \$1,500; equipment use is estimated to cost \$3,000, and man-hours installing the pole is estimated to be \$800.

Partner 3: The Buckeye Trail Association (BTA) has volunteered to assist in trail improvement work. Their volunteer hours are estimated at \$28.54/hour.

Partner 4: The Canton Audubon has volunteered to assist with this project and provide expertise in avian habitat improvements and increasing birdwatching at Clendening Lake. Their volunteer hours are estimated at \$28.54/hour.

Partner 5: The YMCA (Camp Tippecanoe) on Clendening Lake has volunteered to assist with this project. Their volunteer hours are estimated at \$28.54/hour.

Partner 6: The North Country Trail Association (NCTA) has volunteered to assist in trail improvement work. Their volunteer hours are estimated at \$28.54/hour.

Partner 7: Shenandoah K-8 schools has volunteered to assist with this project particularly pollinator habitat preparation and installing wildlife boxes. Their volunteer hours are estimated at \$28.54/hour.

Partner 8: Ohio Prairie Nursery (OPN) has donated \$500 in native wildflower seed for our pollinator habitat.

Partner 9: Ohio Bluebird Society (OBBS) has donated several wildlife shelters boxes and predator guards (baffles) with an estimated value of \$400.
