## E. Describe your partnership and the proposed Handshake Partnership Project:

### **Summary Statement:**

The Turkey Creek Nature Trail is a 0.5-mile, ADA-accessible paved loop trail situated next to the Cordell Hull Lake visitor center, offering convenient access to picnic and playground areas, restroom facilities, and nearby fishing opportunities at the Cordell Hull Dam. The Periwinkle Trail, Cordell Hull's newest hiking addition, stretches 2.65 miles along the lake's shores, meandering through both Smith and Jackson counties. This trail is a collaborative achievement between community volunteers, local businesses, and a partnership with the newly formed Friends of Cordell Hull Lake (FOCHL) and the U.S. Army Corps of Engineers (USACE). In response to the fact that only 27% of children engage in regular outdoor activities, this project aims to create an enriching destination for families. We plan to construct a "Storybook Trail" on the Turkey Creek and Periwinkle Trails. These innovative paths will feature pages from children's books displayed in outdoor frames, allowing the story to unfold as families walk the trail. Each page will prompt activities and foster critical thinking, making the trails a delightful and educational experience that encourages reading and outdoor exploration, while promoting early learning and health literacy.

The second part of this project is a partnership with Kids in Parks. This organization provides the materials to implement kid friendly trails through the installation of interactive self-guided materials that get families unplugged, outdoors, and reconnected to nature. Recent studies show that, on average, kids spend 7.65 hours per day "plugged-in" to electronic devices and only 7 minutes per day participating in unstructured outdoor play. These trends have led to declining visitation rates to parks and public lands and to a myriad of health-related issues for children including childhood obesity, diabetes, and depression. These interactive brochures feature information regarding native plants and animals in an effort to get children engaged with nature. Usage can be tracked online and participants receive prizes for registering hikes on the trail. Intended location for this feature is the Turkey Creek Nature Trail.

### **Handshake Funding Cost Break Down:**

36 posts & frames (Lumber, hardware)\*-\$6,300 (36x\$175), 36 Storybook panels (Max metal)-\$3,600 (36x\$100), Printing and grand opening expenses-\$100, Kids in Parks Trackplus+ package-\*(8,000) = \$20000 (Grand total).

## **O&M Impacts:**

The benefit of this project is the improvement of two trails on Cordell Hull Lake. These additions make the trail more inviting to visitors and aim to garner increased visitation to these recreational areas. The additions/ improvements will be in the trails for the forseeable future and the only maintenance is weeding around the posts and maintaining the wood integrity(if needed). We have agreed with Jackson County Imagination Library and Smith County Imagination Library to alternate children's books with the seasons and ensure they are environmentally educational. The long term cost of this project after the initial installation is nonexistent. When maintenance is required but not funded, this project will not be removed or closed and it will continue to provide the same benefits.

## **Partnership Value:**

Partnerships between the U.S. Army Corps of Engineers and organizations like the Friends of Cordell Hull Lake, Jackson County Imagination Library, and Smith County Imagination Library, and Kids in Parks Track Trails bring invaluable benefits to the Storybook Trail grant initiative. By collaborating, these partners contribute essential resources and expertise, including labor for installation and printed storybook pages, which significantly enhances the project's scope and impact. This synergy not only leverages the strengths of each partner—combining the Corps' operational capabilities with the non-profit groups' community engagement and educational resources—but also fosters a shared commitment to promoting literacy, outdoor recreation, and community involvement. Such collaborative efforts amplify the reach and effectiveness of the Storybook Trail, creating a more enriching and accessible experience for visitors of all ages.

#### **Recreational Value:**

This project holds the promise of significantly enhancing the recreational value of the proposed trails. Located just 10 minutes from the highly popular Defeated Creek Campground—ranked as the #5 USACE campground in the nation and drawing 750,000 visitors annually—this addition is poised to attract even more visitors to the area. The improved trails will enrich the visitor experience by incorporating engaging features such as Ranger-led storybook tours and environmental awareness programs. These guided activities will not only make the trails more appealing but also offer educational and interactive experiences that deepen visitors' connection to nature. By blending recreation with learning, the project aims to create a vibrant and attractive destination for families and outdoor enthusiasts alike.

# **Environmental Stewardship Value:**

The primary goal of this project is to engage the public in environmental stewardship and raise awareness about the importance of protecting our natural resources. By focusing on educating children and families about native plants and animals, we aim to foster a deep appreciation for nature and a sense of responsibility for preserving it for future generations. To support this mission, we have partnered with Leave No Trace, an organization renowned for its expertise in minimizing outdoor pollution and safeguarding wildlife habitats. Leave No Trace will assist us by providing educational materials to remind visitors of the importance of keeping the trail clean and respecting wildlife. These efforts will reinforce our commitment to environmental stewardship and help ensure that our natural areas remain pristine and vibrant for years to come.

#### **Communication & Education Value:**

The proposed trail addition is designed to advance two key goals: communicating our Corps mission of environmental stewardship and educating the public, particularly children, about the value of our natural resources. By integrating educational elements along the trail, we aim to teach children about nature while also encouraging reading and critical thinking. Additionally, this project promotes the benefits of physical activity, family bonding, and outdoor experiences. These improvements not only enhance the educational impact but also foster a deeper appreciation for both nature and wellness among young visitors.

# Supporting Diversity, Equity, Inclusion, and Access Goals:

The proposed trail addition is designed with a strong commitment to diversity, equity, inclusion, and access. First, one of the trails is paved and ADA accessible, ensuring that individuals of all abilities can fully enjoy the new features. Second, we will implement a rotating book schedule that includes Spanish-language books, making our educational resources more inclusive and accessible to Spanish-speaking families. Finally, the trail will feature literature aimed at fostering an understanding and appreciation of diverse cultures and perspectives, helping to create an environment where all children can see themselves represented and valued. These efforts are integral to making the trail a welcoming and inclusive space for everyone.

### **Corps Foundation Bonus Cost Break Down:**

Conclusion: The installation of the storybook and track trails on the Periwinkle and Turkey Creek Nature trails would be beneficial for USACE, Jackson and Smith County Imagination Libraries, the Friends of Cordell Hull Lake, and recreating members of the public visiting the trails. It would allow for the creation of new trail maps with the new features added. Additionally, Cordell Hull Lake and partners are prepared to contribute a sizable portion of the expenses via supplies, equipment, and labor.
