#### E. Describe your partnership and the proposed Handshake Partnership Project:

#### **Summary Statement:**

Kaw Lake has a long-standing partnership with Phillips 66 (P66), Ponca City, and the City of Kaw City. Through this partnership created in 2016, we have accomplished various improvement projects throughout the Kaw Project to include water safety outreach, pollinator fields, fitness trails, playgrounds, safety improvements, etc. In 2024, local Kaw management were approached by P66 for partnership ideas, ultimately landing on the project of constructing a shelter pavilion at Coon Creek Cove PUA adjacent to the previously constructed partnership playground. P66 has offered to invest \$59,750 to build the pavilion with concrete slab, lighting, parking, and sidewalks. This pavilion replaces a previous shelter pavilion located at Pioneer Beach destroyed by the 2019 flood, not expanding our O&M footprint. Handshake funds would be used to finish out the pavilion with tables, family grills, interpretive signages, concrete cornhole boards, and shade canopy for the playground.

## Handshake Funding Cost Break Down:

Picnic tables with several being handicap accessible - \$4,000

Family style cookers - \$1,500

Concrete cornhole boards - \$2,500

Playground shade canopy - \$12,000

Interpretation signage - \$2,000 (Corps Foundation Bonus funds)

### **O&M Impacts:**

As previously mentioned, the Partnership funds offered from P66 will be used to replace a previously destroyed pavilion shelter at Kaw Lake. The handshake funds will allow us to 'finish' out the shelter with no net gain in project funds or cost. As a better management practice, this structure is being constructed at a higher elevation to avoid common flooding and potential damaging impacts. Expected life of this total handshake project would be 40 years, a signicant improvement to the Kaw Project that would not happen without these funds.

#### Partnership Value:

This project, even when funded with handshake money, would not be possible without the financial contributions of our local partners. Our primary funding sponsor is the local Phillips 66 organization, located in Ponca City, OK. Since 2016, we have formed a relationship that has allowed for public recreational development opportunities and community involvement in conjunction with USACE. Outside of funding, members of Phillips 66 along with our other partners will supply crucial support in working with the pavilion contractor and then aid in the eventual volunteer construction event. We look forward to continuing to build upon our partnership with Phillips 66, to include their sub groups of Veteran's Network and New Hire Network, and the City of Kaw City. If Handshake Partnership funding is received, USACE will be able to strengthen our ties with these organizations and hopefully solicit more community involvement for future projects. The funding received would be used to purchase handicap accessible tables, family style cooking grills, interpretation signage of the local history and native species present, shade canopy for existing playground facility, and cornhole boards for recreational usage.

### **Recreational Value:**

This project in its entirety will benefit all users of Coon Creek Cove PUA and Kaw Lake. Currently we do not offer a shelter pavilion for public use at this recreation area, but has been a long requested item from the public to utilize in conjunction with the playground. Campers, day uers, and visiting families would use this facilty for family events and quality recreation time outdoors. Outside of the pavilion, we plan to add standard recreational features such as the cookers, concrete cornhole boards, and shade canopy to better the experience for our visitors. At Kaw Lake we like to believe that these little recreational features take our project from good to great.

#### **Environmental Stewardship Value:**

Perhaps somewhat minor, but an important mssion, we would be utilizing USACE volunteer staff moving forward, post construction. to construct flower beds around the pavilion to plant flowering plants to support pollinator species.

#### **Communication & Education Value:**

A key component of the USACE handshake funds and possible Corps Foundation bonus funds would be to include interpretation panels at the pavilion and playground area showcasing the history of Kaw Lake and highlighting our local practices and missions (prescribed burning, flood protection, pollinator fields, invasive species control). During installation and after completion we would work with our Tulsa District PAO and our local media outlets to share the success story of this partnerhsip/ handshake program to broadcast what we are doing to improve Kaw Lake.

#### Supporting Diversity, Equity, Inclusion, and Access Goals:

Kaw Lake serves a very diverse and inclusive population at our project. This project in particular would be available for use by all visitors to Kaw Lake: camping members, day users, & local community visitors. A prethought notion which drove the idea for this project is to include ADA access to the current play structure. This project would include full handicap accessiblity from the parking lot, through the shelter pavilion, and out to the playground via concrete sidewalks, none of which currently exist.

## **Corps Foundation Bonus Cost Break Down:**

Interpretation panels and signage showcasing the history of Kaw Lake and highlighting our local practices and missions (prescribed burning, flood protection, pollinator fields, invasive species control). Without these bonus funds we may not be able to accomplish the interpretation panels due to high costs of other recreational materials. Funds breakdown as follows: Metal/ Plexi glass sign frames - \$800 Interpretation signage - \$1200

#### **Conclusion:**

Our partnership with P66 & Kaw City has proven to be a multi-year effort to enhance Kaw Lake. With the requested Handshake funds we would not only accomplish our goal of constructing a replacement shelter facility with emphasis on accessibility and family recreation, but we would also show our willingness to support and develop the partnership program at Kaw Lake while potentially attracting new partners to work with in the future. This is a must in todays cultural of flatlined budgets.



#### **Main Building Outline**

Main Building Size: 20' (Width) x 40' (Length) x 10' (Inside of Building Height)

Posts: 6X6 MCA treated, set on 10ft centers. Buried approximately 4' in the ground, back filled and tamped

with dirt.

Truss Spacing: Set on 5' centers, with a top pitch of 3 / 12.

Truss Carrier: The trusses will sit on a Double 2X10 2YP top plate.

**Roof Purlins:** 2X4 2YP set on 2' centers. **Wall Girts:** 2X6 1YP set on 2' centers.

Roof Metal: 26 GA Panel QLOC Plus Roof Color: Forest

Wall Metal: 26 GA Panel QLOC Plus Wall Color: Brown (Open Walls on 4 Sides to Top Plate)

Trim Color: Forest Wainscot: None Overhang: None

Concrete: 4in within the main 20'x40' structure. 4in 20'x40' approach. 4in 4'x60' sidewalk to playground. With

vapor barrier and 3/8th rebar on 2ft centers.
