# **Summary Statement:**

Grant funding would support the development of an accessible archery park in the Opossum Creek Recreation Area. The Opossum Creek Archery Park will endeavor to serve as a valued recreational, educational, and stewardship resource, and support an outdoor heritage that is deeply engrained in the cultural fabric of the region. Backcountry Hunters & Anglers (BHA), Illinois S3DA Conservation Program and Lake Shelbyville Youth Ambassadors, are involved with the development of this project demonstrating strong interest in the project at a local level and beyond. This multiple purpose project is divided into two development phases. This 2023 Handshake Partnership package will fund Phase 1 of the project, and proposes the development of the following facilities: a 15 station 3-D archery trail with target distances ranging from 10 yards to 50 yards and an accessible four station archery practice range. Future development proposes the addition of an elevated shooting platform. Phase 2 of the archery park will be added through future collaborative and funding opportunities. The new Opossum Creek Archery Park facility will support and advance collaborative initiatives, fulfill customer demands, promote quality outdoor experiences for an array of user groups, and support the environmental and recreational missions of the Corps of Engineers.

## **O&M Impacts:**

Due to the durable nature of its components and the minimal infrastructure required to operate the facility, the anticipated operative life span for the Opossum Creek Archery Park is 30 years. Because of the longevity of the project, multiple generations of archers will be able to enjoy the course to hone their archery skills, enjoy the outdoors as well as expereince the benefits of exercise gained from walking the 3/4 of a mile trail system. With routine replacement of equipment, the lifespan of the archery park will be extended. This is an opportunity to maintain continued collaboration with involved partners and involve local youth in projects and activites at the project. Periodic maintenance will be accomplished through efforts of the Lake Shelbyville Youth Amabssadors, and through additional volunteer contributions. The value of contributed maintenance requirement over the 30 year lifespan of the project is \$75,000.00.

#### **Partnership Value:**

In addition to funds contributed by Lake Shlebyville, this innovative project will be accomplished in collaboration with 3 partners including: Backcountry Hunters & Anglers, Illinois S3DA Conservation Program and Lake Shelbyville Youth Ambassadors. Lake Shelbyville Youth Ambassadors include National Wild Turkey Federation,

Pheasants Forever, Lake Shelbyville Fish Habitat Alliance, General Dacey Trail, CIMBA, Lake Shelbyville Muskie Club, Illinois Natural History Survey, Illinois Department of Natural Resources, as well as Shelbyville, Okaw Valley, Central A&M, Sullivan, Beecher City, Windsor, Cowden and Stewardson-Strasburg schools. Backcountry Hunters & Anglers and Illinois S3DA Conservation Program seek to acheive their shared mission of creating outdoor recreational opportunities while maintaining responsible stewardship of public lands. Lake Shelbyville Youth Ambassadors started in 2022 as a way to get school-aged kids involved and engaged in projects and activities at Lake Shelbyville. The estimated project cost is \$86,100.00. Member organizations have pledged support in the form of in-kind and volunteer service valued at \$38,604.00. In-kind services for development include: construction of target standards, construction of 15 station archery trail, construction of covered shooting area at four station accessible archery range, development of site design, and amenity installation. Anticipated maintenance requirements provided by Lake Shelbyville Youth Ambassadors is valued at \$2,500.00 annually, contributing a maintenance value projected over the 30 year lifespan of the project of \$75,000.00. Total project value for facility over expected operational life is \$161,100.00. The involvement from BHA and Illinois S3DA Conservation Program in the development of the new Opossum Creek Archery Park shows an interest for an archery complex centrally located in Illinois. In addition, the project will involve local youth, through the Lake Shelbyville Youth Amabassadors, in all aspects of it's development and maintenance. Exposing them to many differnet trades and mentoring opportunites helping to make the archery park a valued resource and part of the community.

#### **Recreational Benefit:**

The Opossum Creek Archery Park will directly support the recreational mission of the Corps of Engineers, by serving a diverse array of users groups that seek quality outdoor experiences. Access to outdoor archery shooting facilities are extremely rare in this region. In fact, a public facility does not exist in Central Illinois. The flexibility and shooting disciplines accomodated under the design of the Oppossum Creek Archery Park will appeal to a broad range of visitors. The new facility will serve both experienced and ametuer hunters preparing for the season; it will provide a facility for archery education clinics for youth and adults, organized adult and youth competitions; and it will add a barrier-free resource for visitors with mobility limitations. The design proposed under this project will provide a safe environment for new archers to build skills and for experienced archers to hone theirs. It is uncommon for a single recreational facility to accommodate the needs of multiple user groups. The construction of this facility will also provide the staff at Lake Shelbyville a new venue to communicate their message of safe and responsible use of natural resources and public land.

#### **Environmental Stewardship Value:**

The tenets of the Environmental Stewardship mission at Lake Shelbyville are the provision of quality outdoor experiences, the application of responsible stewardship activities, and the promotion of sound conservation principles. The Opossum Creek Archery Park will provide an appropriate platform to communicate the desired ethics of public land utilization, promote a shared value of the wise use of natural resource assets, and propagate an environment of safety in the pursuit of outdoor adventures.

#### **Communication & Education Value:**

The Opossum Creek Archery Park will augment Lake Shlebyville's mission of providing a venue for the collaboration of multiple responsible stewardship and recreational disciplines, and provide a natural and complementary educational asset. It is anticipated that the facility will be a desired resource for regional school organizations, organized youth groups, partnering wildlife management agencies and wildlife benefit organizations to convey the shared value of responsible and safe utilization of public resources. Furthermore, the inviting appeal of this facility to a user demographic ranging in age from youth to adults will further encourage people to re-engage with nature and provide the Corps of Engineers and partnering entities a natural and comfortable setting to communicate relevant educational concepts

#### **Innovativeness:**

The project will represent an achievement of collaboration and will result in a valued community resource. The provision of a facility that consolidates the desired disciplines of this recreational pursuit will yield a resource that will be well-received by outdoor enthusiasts in our region. Furthermore, the concept of federal and state land management agencies, wildlife benefit organizations, civic organizations, educational organizations, and private industry collaborating under a common purpose is innovative and merits much excitement. This project will be

one facility, but will serve many recreational, educational and environmental purposes. It will serve as a keystone of future initiatives, and the advancement of future collaborative endeavors.

## **Corps Foundation Bonus:**

The Opossum Creek Archery Park project fully aligns with the Corps Foundation's mission of suporting USACE recreation and natural resources management programs and nurturing partnerships. This project would help forge strong partnerships with BHA and Illinois S3DA Conservation Program who both promote outdoor recreational opportunities while maintaining responsible stewardship of public lands. The project would also serve as a startup project for the advancement of the Lake Shelbyville Youth Ambassadors and efforts to engage local youth in projects and activities at Lake Shelbyville, i.e. constructing target stands and shelters. The development of the new Oppossum Creek Archery Park will sustain the Corps' stewardship and recreational missions, and will promote a collaborative environment that will stimulate further partnership opportunities with involved partners. Involvement by BHA, S3DA Conservation Program and Lake continues to yield numerous opportunities not being addressed by the current facilities located in Opossum Creek Recreation Area.
