CHALLENGE PARTNERSHIP AGREEMENT

BETWEEN

THE DEPARTMENT OF THE ARMY

AND

THE RAYSTOWN MOUNTAIN BIKING CLUB

THE HUNTINGDON COUNTY VISITORS BUREAU

AND

SOUTHERN ALLEGHENIES PLANNING & DEVELOPMENT COMMISSION

AND

ROTHROCK OUTFITTERS

AND

THE APPALACHIAN REGIONAL COMMISSION

AND

THE NITTANY MOUNTAIN BIKING ASSOCIATION

AND

THE SEVEN MOUNTAINS CONSERVATION CORPS

AND

WADDLE FABRICATION

AND

DUNKLEBARGER CARPENTRY

THIS AGREEMENT, entered into this 24 day of 2015, by and between the Department of the Army (hereinafter the "Government"), and Friends of Raystown Lake, Huntingdon County Visitors Bureau, Southern Alleghenies Planning & Development Commission, Rothrock Outfitters, Appalachian Regional Commission, Nittany Mountain Biking Association, Seven Mountains Conservation Corps, Waddle Fabrication, and Dunklebarger Carpentry (hereinafter the "Partners"), represented by directors, presidents, owners or other designated representatives as identified following Article XI of this agreement.

WITNESSETH, THAT:

WHEREAS, the Government manages lands and waters at the Raystown Lake Project which includes recreational opportunities for the public, and

WHEREAS, the purpose of this partnership agreement is to construct a Allegrippis Skills Park within the Seven Points Recreation Area, which would complement the existing 30+ mile Allegrippis Trail system, and give riders additional riding and training opportunities. The total estimated cost of the facility to the Government and Partners listed herein amounts to \$171,438, and

WHEREAS, Section 225 of the Water Resources Development Act of 1992, PL 102-580, (Oct 31, 1992), authorizes the Secretary of the Army to accept contributions from the Partners and apply those contributions to the Project, and

WHEREAS, it is mutually beneficial to the Government and the Partners to work cooperatively to create, develop, and make available this Allegrippis Skills Park area to the public for the purposes of improving safety along the trail by giving users an opportunity to practice and improve their riding skills in a controlled environment situated in close proximity to roadways and visitor services before riding into remote areas along the adjacent Allegrippis Trails, and

WHEREAS, the Partners, in order to assist the Government in this project, have voluntarily agreed to provide materials, services, and expertise, and

WHEREAS, the Partners are interested in promoting and assisting the Government in providing the Allegrippis Skills Park, and

WHEREAS, the Government and the Partners have the full authority and capability to perform as hereinafter set forth and intend to cooperate in partnership in accordance with the terms of this agreement;

NOW THEREFORE, the Government and the Partners agree as follows:

ARTICLE I - DEFINITIONS AND GENERAL PROVISIONS

For purposes of this agreement:

a. The term "Project" shall mean the environmental review, clearance, and oversight of the approximately 2 acre impact area intended for the skills park; the planning, design, construction, and implementation of the Allegrippis Skills Park for improving mountain bike riding skills; and the treatment of invasive species and subsequent native plantings in the areas immediately adjacent to the Allegrippis Skills Park area.

All work that will be accomplished in the creation of the Allegrippis Skills Park area adjacent to the Visitors Center in the Seven Points Recreation Area of the Raystown Lake Project is described in the Raystown Lake Project Handshake Application, dated and selected for approval by Headquarters U.S. Army Corps of Engineers on 27 November 2014.

- b. The term "total project costs" shall mean all costs incurred by the Government and the Partners directly related to construction of the project.
- c. This agreement in no way restricts the Government from participating in similar activities or arrangements with, or accepting contributions from, other public and private agencies, organizations, and individuals.

d. All donated property, facilities and improvements placed on Government land as well as any work accomplished under this agreement shall become the property of the Government.

ARTICLE II - OBLIGATIONS OF THE PARTIES

- a. The Government, subject to and using funds appropriated by the Congress of the United States (hereinafter the "Congress"), and using funds provided by the Partners, shall expeditiously construct the Project, applying those procedures usually applied to Federal projects, pursuant to Federal laws, regulations, and policies. The award of contracts, modifications or change orders, and performance of all work on the Project (whether the work is performed under contract or by the Government personnel) shall be exclusively within the control of the Government.
 - b. The Government shall provide the following as listed below:
 - (1) The Raystown Lake Project (Partnership Value: \$1,710): Raystown Lake Project Staff will provide oversight and coordination among partners throughout the scope of the project. This includes staff time to oversee volunteer activities and services to design and construct the Allegrippis Skills Park.
 - (2) Handshake (Partnership Value: \$35,000): The Handshake Program will provide the funding for items such as signage, construction materials, benches, fencing, and other items needed for the construction of the Allegrippis Skills Park.
 - c. The Partners shall provide the following as listed below:
 - (3) Appalachican Regional Commission (Partnership Value: \$75,000): The ARC will provide funds to the Friends of Raystown for the labor and equipment to construct the Allegrippis Skills Park features. These will include dirt humps, intricate riding features, and other mountain biking skills areas within the Allegrippis Skills Park area.
 - (4) The Friends of Raystown Lake (Partnership Value: \$17,250): The Friends of Raystown Lake will support this project through a financial contribution toward additional design and construction services. The Friends of Raystown Lake will also provide volunteers to perform hands on raking and other services needed for the Allegrippis Skills Park creation.
 - (5) The Huntingdon County Visitors Bureau (Partnership Value: \$5,000): The Huntingdon County Visitors Bureau will support this project through promotion and information releases in their media guide, website, and other outlets.

- (6) The Raystown Mountain Biking Association (Partnership Value: \$15,678): The RMBA will support this project through in kind services to help with planning, layout, design, and construction of the Allegrippis Skills Park.
- (7) The Nittany Mountain Biking Association (Partnership Value: \$5,300): The NMBA will support this project through in kind services to help with planning, layout, design, and construction of the Allegrippis Skills Park.
- (8) The Seven Mountains Conservation Corps (Partnership Value: \$5,300): The SMCC will support this project through in kind services to help with planning, layout, design, and construction of the Allegrippis Skills Park.
- (9) Dunklebarger Carpentry (Partnership Value: \$1,000): Dunklebarger Carpentry will support this project through in kind services and material donation to assist with planning, layout, design, and construction of features included within the Allegrippis Skills Park.
- (10) Waddle Fabrication (Partnership Value: \$1,900): Waddle Fabrication will support this project through in kind services and material donation to assist with planning, layout, design, and construction of features included within the Allegrippis Skills Park.
- (11) Rothrock Outfitters (Partnership Value: \$5,300): Rothrock Outfitters will support this project through in kind services to help with planning, layout, design, and construction of the Allegrippis Skills Park.
- (12) Southern Alleghenies Planning & Development Commission (Partnership Value: \$3,000): The SAP&DC will support this project through in kind services to assist with the application for, and oversight of the Appalachian Regional Commission grant funding intended for constructing the Allegrippis Skills Park.
- d. The Government shall perform a final accounting to determine the contributions provided by all parties to this agreement and to determine whether each has met its obligations under paragraphs b and c of this Article.
- e. No Federal funds may be used to meet the Partners' total project costs under this Agreement.

ARTICLE III - METHOD OF PAYMENT

a. The Government shall maintain current records of contributions provided by the Partners and a current projection of total project costs. At the completion of the Project the Government shall provide the Partners with a report setting forth all contributions provided, of each party's share of total project costs, and of the Partners' contribution required in accordance with Article II.b. of this Agreement. On the effective date of this

Agreement, total project costs are projected to be \$171,438, and the Partner's contribution required under Article II.c. of this Agreement is projected to be \$134,728. Such amounts are estimates subject to adjustment and are not to be construed as the total financial responsibilities of the Government and the Partners.

- b. The Partners shall provide services required under Article II c. of this Agreement based on funding availability.
- c. Upon completion of the Project and resolution of all relevant claims and appeals, the Government shall conduct a final accounting and furnish the Partners with the results of the final accounting. The final accounting shall establish total project costs, each party's contribution provided thereto, and each party's required share thereof.

ARTICLE IV - DISPUTE RESOLUTION

As a condition precedent to a party bringing any suit for breach of this Agreement, that party must first notify the other partner(s) in writing of the nature of the purported breach and seek in good faith to resolve the dispute through negotiation. If the parties cannot resolve the dispute through negotiation, they may agree to a mutually acceptable method of non-binding alternative dispute resolution with a qualified third party acceptable to both parties. The parties shall each pay 50 percent of any costs for the services provided by such a third party as such costs are incurred. The existence of a dispute shall not excuse the parties from performance pursuant to this Agreement.

ARTICLE V - FEDERAL AND STATE LAWS

In exercise of the respective rights and obligations under this Agreement, the Government and the Partners agree to comply with all applicable federal and state laws and regulations, including, but not limited to, Section 601 of Title VI of the Civil Rights Act of 1964, PL 88-352, and the Department of Defense Directive 5500.11 issued pursuant thereto and published in Part 300 of Title 32, Code of Federal Regulations, as well as Army Regulations 600.7, entitled "Non-discrimination on the Basis of Handicap in Programs and Activities Assisted or Conducted by the Department of the Army."

ARTICLE VI - RELATIONSHIP OF PARTIES

- a. In the exercise of their respective rights and obligations under this Agreement, the Government and the Partners each act in an independent capacity, and neither is to be considered the officer, agent, or employee of the other.
- b. In the exercise of its rights and obligations under this Agreement, neither party shall provide, without the consent of the other party, any contractor with a release that waives or purports to waive any rights such other party may have to seek relief or redress against such contractor either pursuant to any cause of action that such other party may have or for violation of any law.

ARTICLE VII - OFFICIALS NOT TO BENEFIT

No member of or delegate to the Congress, or resident commissioner, shall be admitted to any share or part of this Agreement, or to any benefit that may arise therefrom.

ARTICLE VIII - INDEMNIFICATION

The Partners shall hold and save the Government free from all damages arising from services it performs or provides for the construction, operation, maintenance, repair, replacement, and rehabilitation of the Project, except for damages due to the fault or negligence of the Government or its contractors.

ARTICLE IX - TERMINATION OR SUSPENSION

- a. If at any time either of the Partners individually or mutually fails to fulfill their obligations under this Agreement, the Government shall terminate this Agreement or suspend future performance under this Agreement unless they determine that continuation of work on the Project is in the interest of the United States or is necessary in order to satisfy agreements with any other non-federal interests in connection with the Project.
- b. If the Government fails to receive annual appropriations in amounts sufficient to meet Project expenditures for the then-current or upcoming fiscal year, the Government shall so notify the Partners, and 60 calendar days thereafter either party may elect without penalty to terminate this Agreement or to suspend future performance under this Agreement. In the event that either party elects to suspend future performance under this Agreement pursuant to this paragraph, such suspension shall remain in effect until such time as the Government receives sufficient appropriations or until either the Government or the Partners elects to terminate this Agreement.
- c. In the event that any party elects to terminate this Agreement pursuant to this Article, both parties shall conclude their activities relating to the Project and proceed to a final accounting in accordance with Article II of this Agreement.
- d. Any termination of this Agreement or suspension of future performance under this Agreement in accordance with this Article shall not relieve the parties of liability for any obligation previously incurred. Any delinquent payment shall be charged interest at a rate, to be determined by the Secretary of the Treasury, equal to 150 per centum of the average bond equivalent rate of the 13-week Treasury bills auctioned immediately prior to the date on which such payment became delinquent, or auctioned immediately prior to the beginning of each additional 3-month period if the period of delinquency exceeds 3 months.

ARTICLE X - NOTICES

a. Any notice, request, demand, or other communication required or permitted to be given under this Agreement shall be deemed to have been duly given if in writing and delivered personally, or mailed either by first-class, registered, or certified mail, as follows:
