Memorandum of Understanding Invasive Aquatic Plant Control at Sam Rayburn Reservoir, Jasper, Texas

This Memorandum of Understanding is made and entered into this ____ day of _____, 2010, between the United States Army Corps of Engineers, Lower Neches Valley Authority, and Texas Parks and Wildlife Department.

ARTICLE I: BACKGROUND, PURPOSE, AND OBJECTIVES

The Lower Neches Valley Authority (LNVA), Texas Parks and Wildlife Department (TPWD) and the U. S. Army Corps of Engineers, Ft. Worth District, Sam Rayburn Reservoir Project (COE), have agreed to work in cooperation, where appropriate, for the control of invasive aquatic vegetation at Sam Rayburn Reservoir; Jasper, Texas. This will enable LNVA and TPWD to assist with management/control efforts of invasive species on COE property.

ARTICLE II: RESPONSIBILITIES

Lower Neches Valley Authority Agrees to:

- 1) Designate a Coordinator to work with the Sam Rayburn Project point of contact (POC) and liaison with other agencies/organizations (primarily TPWD) in control of invasive aquatic vegetation, including input in drafting a management plan to begin a systematic approach to controlling vegetation.
- 2) Subject to annual appropriations of funds by its Board of Directors, budget for short-and long-term control of invasive aquatic vegetation to reduce negative impact to industrial water supply, native ecosystems, fish and wildlife habitat and recreation on COE lands at Sam Rayburn Reservoir, and provide other assistance as resources are made available to aid in this control.

Texas Parks and Wildlife Department Agrees to:

- 1) Designate a Coordinator to work with the Sam Rayburn Project point of contact (POC) and liaison with other agencies/organizations (primarily LNVA) in control of invasive aquatic vegetation, including being the lead agency in drafting a management plan to begin a systematic approach to controlling such vegetation.
- 2) Provide expertise and yearly biological evaluation of control, and provide other assistance as resources are made available to aid in this control.

U.S. Army Corps of Engineers, Ft. Worth District, Sam Rayburn Project, Agrees to:

- 1) Work with the Lower Neches Valley Authority, and Texas Parks and Wildlife Department point of contact (POC) to draft a management plan to begin a systematic approach to controlling invasive aquatic vegetation.
- 2) Subject to annual appropriations of funds by Congress, budget for short-and long-term control of invasive aquatic vegetation to reduce negative impact to water supply to LNVA, electric power generation to Southwestern Power Administration, fish and wildlife habitat, and recreation at Sam Rayburn Reservoir and contribute equipment and personnel as available to aid in this control.
- 3) Provide public with information regarding control methods and locations via telephone calls, website, pamphlets, lake maps, etc.

ARTICLE III: CONDITIONS

This proposal serves as an agreement between the Lower Neches Valley Authority, Texas Parks and Wildlife Department, and the U. S. Army Corps of Engineers, Ft. Worth District, Sam Rayburn Reservoir Project (COE). Each party agrees to abide by the terms and conditions stated herein.
