


# HQ Update: Data Quality & Data Management ——

The ability to build, prioritize, and defend funding requests begins with you. **YOU are the one who understands what your project contributes, YOU know your projects priorities, and YOU are the source of complete and accurate data.** If you are new to data entry or the budget process, we encourage you to begin the learning process now. # Water Safety Target: Adult Males

When it comes to promoting water safety, USACE public recreation fatality statistics over the last several years indicates that our target audience has been and remains adult males 18 and older. A continued emphasis is needed when it comes to promoting water safety to adults, and that is where your help is needed!

The last ten-year (FY14-23) USACE public recreation fatality statistics show that of all the fatalities that occurred 88% were male, 86% were 18 and older, and 89% were not wearing a life jacket. 47% occurred in undesignated swimming areas, 21% were falls from boats, docks, and shore, and in 19% alcohol was involved or suspected.

Please take a few minutes to look at how your project is promoting water safety. What can you do, and what can we do, to increase the number of direct interpretive contacts made with adults and what are ways to increase life jacket wear? Whether your initiative is big or small, focus it on adults. Possibly include such things as giving water safety talks to local adult groups or businesses, at fishing tournaments, community events, boat shows, etc. Conducting roving interpretation at boat ramps, campgrounds, beaches, and marinas can be very effective at reaching our target au-



dience. The sky is the limit, so think outside the box when it comes to finding creative or different ways to educate our visitors on water safety.

The Life Jackets Worn...Nobody Mourns campaign is our water safety campaign for adults. Campaign resources have been developed by the National Water Safety Program with help from The Corps Foundation and are available for your use. They include a resource guide, video PSAs, audio PSAs in English and Spanish, logo, posters, publication ads, and artwork for banners, billboards, vehicle tailgate vinyl wraps, etc. All can be downloaded from the National Water Safety Program's webpage, <a href="https://www.usace.army.mil/Missions/Civil-Works/Recreation/National-Water-Safety\_Program/">https://www.usace.army.mil/Missions/Civil-Works/Recreation/National-Water-Safety\_Program/</a>, which PleaseWearlt.com redirects to. The National Water Safety Program's "Please Wear It" page on Facebook and Instagram, managed in cooperation with The Corps Foundation, is a library of water safety social media posts that focus on the campaign. You can reshare these posts as they are or pull assets from them to create your own posts. The National Water Safety Program continues to work with The Corps Foundation to provide promotional products that can be used as part of the "I Got Caught" initiative. Those products will be available for you to request later this year, so keep an eye out for an email from your Division Representative on the National Water Safety Committee.

Other resources are available on the NRM Gateway in the water safety section including USACE Water Safety Resource Guide for Interpretive Services and Educational Outreach under good enough to share, Life Jacket Mandatory-Wear Policy Selective Expansion memo under policy and procedures, USACE public recreation fatality statistics under water safety program statistics, issues of "Ripples" water safety journal under water safety journals, and much more. # Water Safety: EM 385-1-1

The new Engineering Manual 385-1-1 (Safety and Occupational Health Requirements Manual) is signed and published, with an effective date of Mar. 15, 2024. This has been a significant effort over the last few years as this was not just an update but a complete rewrite of the manual. There are a few important changes related to water safety in the manual revision.

### Chapter 1. Personnel Required Qualification/Training.

- (7) Employees and volunteers that work around water must be provided basic water safety training to include the following:
- (a) The "Reach, Throw, Row, Don't Go" method.
- (a-1) Reach. Hold on to the dock or your boat and reach your hand, a boat oar, a fishing pole, or whatever you have nearby, to the person.
  - (a-2) Throw. If you cannot reach far enough, toss things that float for the person to grab.
- (a-3) Row. If you are in a boat, use the oars to move the boat closer to the person in the water, or call out to a nearby boat for help. Do not operate the boat's motor close to a person in the water, they could be injured by the propeller.
  - (a-4) Don't Go. Do not go into the water unless you are trained. Call for help.
- (b) Hazards associated with working around water (for example, temperature, depth, current)
- (c) Hands-on training on how to use rescue equipment (for example, throw rings and bags) and personal protective equipment (PPE) (for example, personal flotation devices (PFD)) properly.

### **Chapter 19. Floating Plant and Marine Activities.**

19-5.g All motorboat operators must inspect and use the vessel engine cutoff device (kill switch) and safety lanyard and attach the safety lanyard to their person (exclusive use of wireless kill-switch devices are not authorized).

To help with the requirements, the National Water Safety Program created some water safety information and presentations that can be used when training employees and volunteers.

# Infrastructure Investment and Jobs Act Work In Action

Coralville Lake (MVR) - The Coralville Lake Project received funding for specific work packages through the IIJA. Four prefabricated CXT restroom and shower buildings were procured utilizing this funding. The new restroom buildings meet the sustainability guidance and re-place old buildings that had reached the end of their lifecycle. The CXT buildings required minimal site preparation and were delivered ready to use including plumbing and electrical requirements.







New Melones Dam (SPK) - IIJA work at the Stanislaus River Park at New Melones Dam consisted of plac-ing approximately 6,300 tons of class II road base to cover 338,000 square feet of non-paved road accesse the Horseshoe Road, Oakdale, Knights Ferry, and McHenry Ave recreation areas. Work also included paving a 0.46 mile section of roadway and approximately 65,000 sq-ft of public parking area at the Oakdale recreation area. The contract work included delivery of supplies, installation, mobilization/demobilization, pulverizing the existing pavement, excavation, disposal of excavated materials, subgrade preparation, placement of asphalt, shoulder repairs, and striping.

This project benefits the community by making road conditions safer by eliminating cracks and holes that can cause injuries, reducing the risk of skidding on slick surfaces, and providing recreators, project staff, and first responders better access to the recreation areas.

# Workamper

Now is a great time of year to advertise paid or volunteer camp host positions through the Workamper website.

HQ USACE pays for an annual, nationwide contract that provides each USACE project with 10 help-wanted ads per year at no cost to the project. You also get unlimited searches in Workamper's *Awesome Applicants Online Resume Database*. Additionally, projects can create an Employer Tour or podcast on the website.

Last year, 168 USACE projects were signed up as members under the national contract, but only 55 projects posted an ad. Only 68 of a possible 1,200 ads were placed. This year between Aug-Dec, only 38 of a possible 500 ads were placed.



# **Corps Watch**

The Corps Watch program is undergoing a new look and transitioning to local-based reporting. The national hotline is ending and will no longer be available. Visitors are encouraged to report issues locally. Since 2008 when Corps Watch was first established, the national hotline provided a standardized resource for public criminal activity reporting. As access to cellular telephones and smartphone technology increased, the usefulness of the centralized national hotline decreased. Visitors are still encouraged to report any suspicious activity or vandalism to local law enforcement and local USACE project office.

The USACE Innovations Team and the Park Ranger Advisory Board are working on potential updates to the Corps Watch program and integrating new technologies for public reporting. Any signs or posters displaying the national hotline phone number 1-866-413-7970 should be removed. New poster graphics are being made available and posted on the NRM Gateway.

The SmartBook provides an electronic directory making it easy to connect with others in your respective CoPs. Revamped in April 2021, the SmartBook includes members of the NRM, Park Ranger, and OPM CoPs. The SmartBook enhances communication with program points of contacts, subject matter experts, and other individuals. The SmartBook offers connections and workforce context information far beyond what a DLL mailing list or an Outlook search can produce.

The SmartBook works best when everyone periodically reviews and updates their personal (and their teams) information regarding areas of expertise, PDT membership, location, and other organizational information. The SmartBook is only accessible from the army.mil network and requires CAC card for access.

# **Recreation Around USACE**

1 Farm Creek Project (MVR) - To conclude their Eagle rank project, Scouts designed, built, and installed a preparation table and multiple benches at the Farm Creek Project. Assisted by Park Rangers, the Scouts removed cedar and walnut trees that were encroaching on project roads and trails, which were then sized and prepared for use in the project. Additionally, the Scouts removed invasive bush honeysuckle to promote native vegetative growth.

Lake Washington Ship Canal (NWS) - In recent years, NRM leadership has encouraged USACE projects to develop or expand the implementation of recreation use fees using existing authorities. Lake Washington Ship Canal will begin collecting Special Use fees during the FY24 season (May 1—Oct. 31, 2024). A minimum of two full time NRM staff are tasked with administering the Fee Program daily. Fees will be collected through R1S exclusively (no cash will be collected). Active messaging is oc-

curring with the public to ensure awareness regarding the new fees in collaboration with Seattle Districts public affairs office. Additionally, a cost comparability report is planned to recommend changes, or no change, to the fees assessed.

Hopkinton-Everett Lakes (NAE) - A new snowmobile crossing was constructed near the South Weir at

Hopkinton Everett Lakes. The crossing was constructed by Weare Winter Wanderers in coordination with the State of New Hampshire Bureau of Trails. Park Ranger Pascal Carter attended the ribbon cutting ceremony on Jan. 6, 2024. The Hopkinton-Everett multi-use trail system is maintained by the New Hampshire Bureau of Trails and the Merrimack Valley Trail Riders and were established through cooperative efforts with USACE. Hopkinton-Everett Lakes provides approximately 26 miles of designated OHRV trails and over 30 miles of designated snowmo-

bile trails.

# **Recreation Across USACE**

**Libby Dam** (NWS) - The Libby Dam Disc Golf Courses, visitor center, and campgrounds were host to the Montana State Disc Golf Tournament. Over 175 participants of all ages plus family and friends attended the event. Libby Dam has hosted disc golf tournaments annually since 2010 and has hosted the state tournament three time due to the complexity and challenging design of the course. This has been a popular event made possible by the support of active partners in outdoor recreation.





Wappapello Lake (MVS) - Wappapello Lake in partnership with the Wappapello Lake Area Association (WLAA), and River Radio hosted the 31st Annual Festival of Lights Auto Tour during the 2023 holiday season. For over 30 years, this free, family-oriented event has provided visitors a beautiful drive-thru light display to enjoy from the safety and comfort of their own vehicle. Local businesses, church groups, organizations, and families decorate campsites in the Redman Creek West Campground. Over 36,500 visitors attended the event. This annual event provides a major boost to the local economy and increased visitation to Wappapello Lake. Additionally, it serves as an opportunity to support and establish local partnership, promote community involvement, and utilize volunteers. USACE staff are able highlight our missions and provide water safety education.



Saylorville Lake (MVR) - Saylorville Park

Rangers Benjamin and Phipps were dispatched in response to a 911 call to the Cherry Glen Boat Ramp for kayakers stuck near the breakwater. The occupants of the kayak were unable to get their vessels to shore due to wind gusts over 20 mph. Rangers were able to help both occupants and get their vessel to shore!
