1. EXSUM: Effective immediately, the U.S. Army Star Logo is authorized for display on all classes of USACE vessels. Display of the Army Star Logo on Class 2, 3, and 4 self-propelled floating plant is mandatory. Display of the Army Star Logo on Class A and 1 self-propelled floating plant is optional. All Army Star Logos displayed on USACE vessels will be done so in accordance with Attachments 1 and 2 of this DTO.

2. BACKGROUND: To increase public awareness of the connection between the U.S. Army and the U.S. Army Corps of Engineers, the Army Chief of Staff has directed the U.S. Army Star Logo to be displayed on U.S. Army Corps of Engineers vessels.

3. SUSPENSE: NLT 90 days from the date of release of this DTO, all Divisions who own Class 2, 3, and 4 self-propelled floating plant will acquire and affix the U.S. Army Star Logo on those vessels that are currently in service and or placed in service following that date.
