Uniform Items	I realize most of the employees who use the uniforms are park rangers who rarely encounter adverse environmental working conditions, but someone, somewhere needs to know that there are a few folks who work under more adverse conditions than rangers typically work. I'm not sure all uniform administrators realize that foresters and biologists encounter extremely difficult environmental conditions (briars, brush, green briars, etc.) during timber cruising, timber marking, tree planting, food plot planting, prescribed burning, wildlife population surveys, etc. that warrant the use of much tougher clothing items than are offered by the current uniform program. As a forester, I would like to see a tougher fabric/material used for pants/jeans. We need a material similar to the Carhart brand of clothing which is a 12 oz. cotton duck cloth. I would also like to see an overall (not a coverall) type garment offered. This would offer chest/upper body protection when "brush busting" in thick cover. These garments could also have a "double knee" or extra layer of material in the front part of the leg for more durability and protection. Uniform Items	As in the past, I would like to see t-shirts or polo shirts added to the class B and C daily wear uniform. The summer class B shirts do not cool effectively and do not dry from sweat quickly. Rangers' duties constantly require them to perform duties in an outdoor setting during hot summer months in antiquated apparel that is uncomfortable. It is my opinion that a "Professional-looking" alternative could be made available. I would also like to see the cargo pant be made part of the class B daily wear uniform. The cargo pant does not detract from the professional image we are trying to put forth and they are very handy for the jobs we must perform as rangers.		The committee recommended against the t-shirt. The polo shirt is being designed. The Cargo Pants are being recommended by the committee to be available for both Class B daily and Class C work uniforms. Uniform Items	As a female uniformed ranger, I would prefer to wear a shirt that can be worn on the outside of my uniform pants for several reasons. 1) The amount of shirt that has to be tucked in is excessive and causes a bulky appearance. 2) The area where the shirt and pants overlap is extremely warm and causes heavy sweating during hot weather - especially the hot temperatures we experience here in the South. 3) It is a neater (and might I add, more feminine) appearance for female rangers. I am not ruling out the shirts that are presently being used, but I am asking for an alternative for those of us who would like to be cooler and to have a bit sharper appearance. The alternate style of shirt would help us to keep our identity as both park rangers and women. The style of shirt that I am referring to is also the shirt worn by females in the Armed Services, so it should not require the design process.		The committee recommended against this item.
