Assisted Lake Ouachita staff with staffing a booth at the Hot Springs Boat Tackle & RV Show. Assisted Little Rock District staff with staffing a booth at the 48th Annual Arkansas RV Show. Provided solar eclipse glasses to the public that had the Life Jackets Worn...Nobody Mourns logo on them.

#### Louisiana Field Office

Swim For Life is a program that guarantees every second grader in Caddo Parish receives instruction in swimming and water safety. Every week a group of 80 - 120 second graders come to the BHP YMCA 4 days in a row, and every day the YMCA does 30 minutes of in-water instruction and 30 minutes of classroom instruction. The in-water skills are bubble blowing, rescue bounce, floating, swimming, and jump-push-turn-grab. The classroom portion includes the big water rules like asking permission and never swimming alone, the dangers of natura 1 bodies of water, how to identify and wear the right life jacket, and "Reach Throw Don' t Go".





# St. Paul District (MVP)

### Mississippi Headwaters Project

Staff provided water safety programs at local schools. During the programs, the water safety video, "Safe Passage", produced by the National Water Safety Program is shown. The video is followed by discussion on the importance of wearing a life jacket. They also included a water safety ad in a local lake association newsletter.

#### Eau Galle Recreation Area

Worked with local newspaper to have a water safety ad placed in the newspaper.

Staff attended local boat and travel sport shows to promote water safety and talk to attendees about the Corps mission. Public Affairs and Lock and Dam staff also helped staff the booths.





Lake Ashtabula

Staffed local boating, travel, and outdoor recreation sport shows. Utilized a low head dam model, life jackets, and other interactive presentations to engage attendees.

# St. Louis District (MVS)

The St. Louis District Water Safety Team was awarded the Mississippi Valley Division Water Safety Award for their water safety initiatives and efforts in having no public recreation fatalities in FY23. FY23 was the first year there were no public recreation fatalities in the St. Louis District since FY98 when the National Water Safety Program started tracking fatalities.





Park Ranger Tanner Canoy was awarded with the Star of Life Award for his fast action while on patrol that saved a life at Wappapello Lake.

### Carlyle Lake

The groundwork for their annual "I Got Caught" initiative started in March, rallying support from local businesses. This year 35 partners will be involved in the lake's efforts to promote water safety through their "I Got Caught" initiative.



Water safety messages were displayed on digital reader panels along a local state highway and on all day-use recreation area information boards.





Water safety social media posts provided by the National Water Safety Program were posted on the lake's Facebook and Instagram pages generating a total of 43 posts with a total of 359 likes, comments, and shares.

### Kaskaskia River Project Purchased a water safety message design from Put-In Cups and placed it on the fence near the entrance to the only gate at the Jerry F. Costello Lock and Dam.

Staffed an interactive area at the annual Southern Illinois



Conservation Fair where approximately 200 students learned about water safety and soil erosion.

Built five new life jacket loaner stations that will be put in place this recreation season.

#### Rend Lake

Park rangers presented their "Many Hats of the Corps" program at a career day event at Sesser-Valier High School. The park rangers emphasized the many roles of a USACE park ranger including water safety. The programs also included water safety trivia for the students to participate in.

Continued to promote water safety through unique social media messages and placed water safety messages on their visitor center electronic marquee.



### Rivers Project Office

On January 26, 2024, in partnership with the City of Clarksville and in conjunction with Clarksville Eagle Days, Rivers Project staff and volunteers conducted Eagle Education Day. Seven regional schools totaling 250 4th grade students participated in the event. They learned about navigation, natural resources, and water safety. The public portion of the event took place on January 27 and 28, 2024. Park rangers provided tours of the dam and staffed a water safety information table. Approximately 900 direct water safety interpretive contacts were made.



Over 600 visitors attended the event. Event attractions included tours of Melvin Price Locks and Dam, live animal presentations, live music, educational booths, and visits from Bobber the Water Safety Dog and the St. Louis Blues Hockey Team's mascot, Louie. Additionally, a special water safety Polar Passport was given to children who visited all ten of the educational booths at the event.

### Lake Shelbyville

Seasonal water safety messages are added to the electronic message panel that is located along a state highway in front of the visitor center and project office.









Partnered with local movie theater to run water safety public service announcements before every movie starts. A different water safety message is highlighted every month.

# Rock Island District (MVR)

### Saylorville Lake

Staff contributed information that is included in the 2024 Saylorville Lake Area Recreation Guide. Inside the recreation guide is information about the lake and recreation areas in the area. One of the most important things in the guide is the water safety ad and information about life jacket stations available at the lake.



On January 24, 2024, park rangers and volunteers staffed a water safety table at a Iowa Wild Hockey Game in the concourse area of the arena. Approximately 150 direct water safety interpretive contacts were made.



### Coralville Lake

Park rangers promoted water safety at two hockey games near the lake, Heartlander's in Coralville, IA and Rough Riders in Cedar Rapids, IA. Bobber the Water Safety Dog made appearances and participated in mascot games. Over 5,750 direct water safety interpretive contacts were made.



Park rangers staffed water safety booths at two community events, Winterfest and Freeze Fest. Activities provided at the booths included a ring toss activity. 775 direct water safety interpretive contacts were made.

Park rangers staffed a booth at the Cedar Rapids Outdoor Show to promote water safety and provide information on Coralville Lake. 1015 direct water safety interpretive contacts were made.



### Illinois Waterway Project

Distributed water safety information to 658 students at their 4th and 5th grade Eagle Watch Weekend school program.

Provided water safety information to the Illinois River Regional Boater Association's Late Winter gathering. Over 100 boaters were in attendance.

On March 11, 2024, presented water safety information at the Monthly Senior Lunch Program held at the Illinois Valley YMCA.

### Mississippi River Project

On February 15 - 18, 2024, staffed a booth at the Hunting, Fishing, and Outdoor Show in Rock Island, IL Information regarding water safety, river navigation, upcoming boater safety classes was provided during the event. 1,491 direct interpretive contacts were made.

Staffed a booth at Quad Cities Bald Eagle Days that included provided attendees with water safety information. 3,432 direct interpretive contacts were made.

#### Lake Red Rock

During a weekly safety meeting for staff, a Cold Water Boot Camp video was shown to review the dangers of cold-water immersion and ways to increase chances of survival.





Park rangers created a scavenger hunt to encourage kids to explore the Lake Red Rock Visitor Center. One task on the hunt includes searching for several small graphics of Bobber the Water Safety Dog that are hidden throughout the visitor center. Kids receive a Junior Ranger Badge sticker as a reward for their efforts.

Park rangers utilized graphics from the Bobber the Water Safety Dog activity book to create a temporary display in the Lake Red Rock Visitor Center. The display highlights the Reach, Throw, Row, Don't Go message and throw ring challenge using the water safety flying rings provided by the National Water Safety Program to hook an orange cone.


### West Hill Dam

In March 2024, Park Ranger Viola Bramel conducted life jackets fittings and shared water safety information at the Milford Family Fun and Disability Fair and the annual Kids Safety Fair. Approx. 2,700 visitors participated in the fun during both of these events.

# **Baltimore District (NAB)**

### Raystown Lake

This January marked one year since the harrowing near-drowning incident involving an 18-year-old male at Raystown Lake. On January 21, 2023, Mr. and Mrs. Ford (pictured on the right) were taking a stroll through Senoia Campground in Seven Points when they witnessed a young man attempting to swim after his drifting boat. It's worth noting that the lake temperature was a bone-chilling 37°F, with the air not much warmer at 38°F. The Fords watched in alarm as the 18-year-old swam out to his boat, which had floated about 200 feet from the shoreline. Miraculously, he managed to haul himself back into the boat from the icy water, start the engine, and navigate it back to shore. However, upon reaching land, he had totally lost control of his extremities due to



coincidentally in the area on his day off, arrived within five minutes of the 911 call. Park Ranger Graham provided the 18-year-old with a wool blanket and ensured he remained conscious by engaging him in conversation until further emergency assistance arrived. Reflecting on the incident, Ranger Graham emphasized, "Two factors saved the 18-year-old's life: the fortuitous presence of the Fords, who coincidentally happened to be walking in an area that's off-the-beaten path during a slow time of year, and his decision to wear a life jacket. This situation could easily have ended in tragedy. I was reminded of the importance of staying vigilant and being prepared for anything, even during the off-season and on one's day off." Unfortunately, the 18-year-old's ordeal didn't end there. Despite receiving treatment for hypothermia at the hospital, he faced another health crisis a few days later. He had

to be readmitted due to acute renal failure stemming from Rhabdomyolysis, a condition triggered by severe muscle strain caused by swimming a long distance in extremely cold water. Following a week-long hospitalization, his kidneys began to show signs of improvement, and he eventually made a full recovery.

### Northwestern Division Water Safety Initiatives

# Kansas City District (NWK)

A representative with Bass Pro Shops contacted Pomme de Terre Lake and offered to make a donation of life jackets worth \$9,500 that could be used to supply life jacket loaner stations. All that the Corps of Engineers had to do is pick up the life jackets and distribute them to the lakes within NWK. Shannon Henry, Natural Resource Manager and the Pomme de Terre staff facilitated the distribution effort.







Kansas City District's Public Safety Team partnered with the Kansas City Mavericks Hockey Club to promote water safety during their Scout's night. Bobber the Water Safety Dog made appearances during the event. Over 5,800 direct water safety interpretive contacts were made.

# Portland District (NWP)

John Day Lock and Dam

Park Ranger Volkman staffed a information table at a Career Day event hosted by Columbia High School in White Salmon, WA. 200 direct water safety interpretive contacts were made.



Willamette Valley Project



Partnered with the Bureau of Land Management and U.S. Forest Service to staff an area at the Eugene Boat and Sportsmen's Show. Seven USACE Park Rangers and two USACE Fish Biologists worked the three day event in the beginning of February 2024. Carla Robinson, former USACE employee and SPD Representative on the National Water Safety Committee now works for the Forest Service and helped staff the Forest Service's portion of this event. Each year, the three agencies establish a theme for



the Boat and Sportsman's Show to highlight topics they would like to communicate to the public. This year, they designed a Leave No Trace (LNT) display to discuss visitors' knowledge on the 7 Principles of LNT. The agencies promoted safety, preparedness, and preferred outdoor practices. About 1,600 visitors interacted with the staff and the display. Visitors had the opportunity to win water safety giveaways when they spun the "LNT activity wheel" or rolled the LNT dice. They answered questions about the LNT principle they landed on and provided an example how they would follow it. People of all ages

were attracted to the display and left learning how to recreate responsibly in the outdoors.

At the NWD NRM Conference, participated in bringing a Good Enough to Share display to the workshop. The display focused on water safety materials that were designed in the Willamette Valley Project staff. Several artwork proofs and products were available for NWD employees to view. The display offered unique ideas to

# Walla Walla District (NWW)

Lower Granite Natural Resource Management Office

Manages three developed water recreation sites within Whitman County, WA that are open to the public on the Lower Snake River. Park Ranger James Norris, Park Ranger Robert Wiggins, and volunteers staffed a booth at the 50th Annual Stuart Boat Show. By participating in this 3-day event on January 12-14, 2024 park rangers and volunteers were able to share water safety messages, develop professional and community relationships, and inform the general public of the work that the USACE park rangers conduct on the Okeechobee waterway. 783 direct water safety interpretive contacts were made at this event.

This event is one of the biggest of the winter season, as this parade draws an estimated 15,000 attendees. During the parade park rangers and volunteers promoted water safety by wearing their life jackets with Bobber the Water Safety Dog on

board their trailered patrol boat. The parade announcers helped promote water safety by reminding the parade attendees to "always wear their life jackets!"

On March 9, 2024, Park Rangers Megan Parsons and Rob Hill promoted water safety and talked about Florida native and invasive plants at the Annual Plant Sale & Strawberry Festival in Alva, FL. This event was hosted the Alva Garden Club. A total of 275 direct water safety interpretive contacts were made during this event.



On March 16, 2024, Park Rangers Megan Parsons, Jorge Leyro-Montalvo, and Preston Heaton and volunteers staffed an information area at the 2024 Clewiston Sugar Festival in Clewiston, FL. Volunteers and park rangers staffed a water safety information table, as well as their interpretive trailer that is used to teach the public about the history of the Okeechobee Waterway and USACE missions. Nearly 2,000 direct water safety interpretive contacts were made.

Hensley Lake Park Ranger Shawna Polen volunteered and was chosen to be a panel speaker during the conference. She spoke on the USACE loaner station guidelines, public engagement, and tips for retaining life jackets.



### Black Butte Lake

On March 21 2024, Park Rangers Mylaina McMurray and Ethan Renaud, and Project Admin Christina Tice conducted a water safety program at Plaza Elementary, instructing over 120 students and 14 adults on water safety and recreational hazards. Student and school staff received an interpretive program and then students and staff moved outside to participate in waters safety games. Games included the Cold Hand Luke where students plunge their arms into a 5-gallon bucket of ice water and attempt to unscrew a bolt. This challenge demonstrated the effects of what cold water can do to a body. The next game was a life ring toss. This helped train students on the real-world application of tossing a life ring towards a person that may be drowning. Students then participated in a life jacket relay where students had to sprint to a life jacket, put it on, and then run back to the starting point. Rangers used this as a teaching point to helps students recognize how difficult it is to put on a life jacket under stressful situations.

Ranger Ethan Renaud coordinated with Eagle Scout candidate Johnny Methvin-Terry to construct a life jacket loaner station in Buckhorn Recreation Area. With the assistance of 15 other Scouts John oversaw the design and construction of the station. This highly visible station constructed with a roof and walls will prolong the life of the life jackets.

#### Lewisville Lake

Park Ranger Heffernan explained the importance of and how to select a proper fitting life jacket, and "Reach, Throw, Row, Don't Go" was explained and practiced.

### Belton Lake



Park Rangers Katriana Joyce and Cassy Hill staffed an information table at the Harker Heights Youth Science Expo to teach about the importance of water safety and the use of life jackets in and around the water.

### Georgetown Lake

Park Rangers Tanner Creel and Josh Houghtaling presented water safety programs to McCoy, TX Elementary School. The park rangers provided water safety tips that will help the students be safe while visiting Lake Georgetown and San Gabriel River and showed the students how to properly wear a life jacket.



Park Ranger Tanner Creel and Bobber the Water Safety Dog attended the 12th Annual Georgetown, TX Police Department's Chase The Chief event. This event is done to promote "Georgetown Get Fit Initiative" with healthy living, exercise, and getting outdoors. Over1,100 direct water safety interpretive contacts with kids, parents, and grandparents were made.

### Stillhouse Hollow Lake

Park Rangers Madison Wetterstroem and Alex Klepac presented programs at a career day at House Creek Elementary School in Copperas Cove, TX. They talked to over 400 students about the duties of a park ranger, the importance of wearing a life jacket, and how to properly wear a life jacket.

Park Rangers Madison Wetterstroem and Alex Klepac coordinated with their public affairs office to produce a PSA informing the public about the newly installed life jacket loaner stations and how to use QR codes to pay day use fees.

#### Navarro Mills Lake



Park Rangers Casey Hackler and ReAnna Carpenter staffed an information table at the Texas Waterfowl Symposium. This event brought together over a hundred attendees for waterfowl education from a variety of public and private entities. The park rangers educated attendees about hunting and recreation opportunities at Navarro Mills Lake and the importance of water safety when on or near water.

On March 8, 2024, staff and visitors witnessed the solar eclipse. Being within the path of totality, Navarro Mills Lake saw numerous out-of-state visitors and even some travelers from other countries like Belgium and Germany. Park rangers took this opportunity to spread awareness for water safety by installing water safety banners in all the parks and provided water safety information to their campers.

#### Waco Lake

On March 11, 2024, Park Rangers Matthew Hackler and Taylor Christian, along with SWF Regulatory Project Manager Brian Bartels presented programs at the Lake Waco Wetlands Career Day for Lorena, TX students. They provided information on what they do for USACE, college degrees, benefits of working for USACE, and how to gain experience through volunteer or internship opportunities. Park Rangers Hackler and Christian also presented a water safety program, which covered the 7 Deadly Swims, Reach Throw Row Don't Go, items are required on a vessel, and how to



properly select and wear a life jacket. Sixty students participated in the presentations.



On March 26, 2024, Park Rangers Matthew Dutton and Taylor Christian gave presentations at the Lake Waco Wetlands to fifty-three 5th grade students from Mountainview, TX Elementary. Ranger Dutton provided information on water safety, how to properly wear a life jacket, and "Reach, Throw, Row, Don't Go" to keep the kids safe during the spring and summer months. Ranger Christian provided information on invasive species identification and prevention, especially regarding zebra mussels.

On March 22, 2024, Park Rangers Matthew Dutton and Matthew Hackler staffed a table at the World Water Day event at Independence Park in Waco, TX. Keep Waco Beautiful sponsored this event in partnership with the City of Waco. The purpose of the event was to educate the public on all aspects of water and our watersheds. The park rangers educated the public on water safety and invasive species prevention during the event.



On March 27, 2024, Park Ranger Matthew Hackler assisted Waco, TX ISD with a film project highlighting Waco landmarks. The short film is titled "Goodnight Waco" and was inspired by the children's book Goodnight Moon. Ranger Hackler talked about Waco Lake including the history of the lake, geography, and water safety. The filmmakers hope to premier the film at an upcoming Waco event before using it to orient Waco ISD students to what makes their city great.

Proctor Lake

Park Rangers Jared Harris and Elyssa Mendez conducted a water safety presentation at Stephenville, TX school. They explained the importance of wearing a properly

fitted life jacket and the how to help someone drowning.

Sam Rayburn Lake, Town Bluff Project, Lake O' the Pines, and Wright Patman Lake March 21-31, 2024, park rangers travelled to Beaumont, TX to staff a booth at the regional state fair. Park rangers educate thousands of people on water safety, recreational opportunities, and invasive aquatic species.

# Galveston District (SWG)

### National Water Safety Program Resources and Initiatives

Our target audience is adult males (18 and older) not wearing life jackets because our statistics from FY98-23 show that 88% of our public recreation fatalities were male, 82% were 18 and older, and 89% were not wearing a life jacket. Ten year statistics (FY14-23) show that 88% of our public recreation fatalities were male, 86% were 18 and older, and 89% were not wearing a life jacket, so please focus on promoting water safety to adult males and increasing life jacket wear.



The Life Jackets Worn...Nobody Mourns campaign is our campaign used to promote water safety to adults. Life Jackets Worn...Nobody Mourns promotional items from the National Water Safety Program should only be used to promote water safety to adults.



The Bobber the Water Safety campaign is our campaign used to promote water safety to kids. Bobber the Water Safety Dog promotional items from the National Water Safety Program should be used to promote water safety to kids.

### National Water Safety Committee Meeting Conducted at Cape Cod Canal Project

On March 12 - 14, 2024, the National Water Safety Committee Meeting was conducted at Cape Cod Canal Project in Massachusetts within the New England District. During the meeting the committee discussed USACE public recreation fatalities and trends, items regarding water safety in the updated safety manual (EM 385-1-1), promotional products, updating USACE Strategic Plan for Reducing Public Recreation Fatalities, Water Safety Forum for Commanders conducted by MG Graham, quarterly water safety journal, Bobber the Water Safety Dog and Life Jackets Worn...Nobody Mourns campaigns, monthly social media post lists, National Water Safety Awards and Photo Contest, and bilingual subcommittee and created a list of things that can be done to help reduce the loss of loaner life jackets. Park Ranger Samantha Gray provided the committee the history and update on water safety initiatives at the Cape Cod Canal and along with other USACE employees provided a tour of the project.

The six interpretive program training videos include Captain Alcohol, Cold Hand Luke, Flotation Fashion Show, Safety First and Always, Sink Fast, and Sink or Float. The nine roving interpretation training videos include boat show scenario, cleat hitch knot, inflatable life jackets and float coats, I Got Caught, life jacket loaner station, overestimating swimming ability, photo op frames, signs of drowning, and vest type life jacket not worn properly.

# Life Jackets Worn...Nobody Mourns Video PSAs (public service announcements) and "Inflatable Life Jackets: Everything You Need to Know" educational video

A total of 53 Life Jackets Worn...Nobody Mourns video PSAs (60, 30, and 15 seconds) and a nine minute "Inflatable Life Jackets: Everything You Need to Know" educational video have been created by the Corps of Engineers Natural Resources Education Foundation (The Corps Foundation) in cooperation with the National Water Safety Program. These are outstanding videos that you can use to promote water safety to adults, primarily men. ### Life Jacket Video Contest

The Corps Foundation has been conducting a Life Jacket Video Contest since 2020 in cooperation with the National Water Safety Program. Some of the 53 Life Jackets Worn... Nobody Mourns video PSAs mentioned above were developed from winning entries and other entries from this contest. The Corps Foundation utilizing U.S. Coast Guard grant funds pays the 55-second video winner \$5,500 and the winner of the 25second video \$2.500. Deadline for the 2024 video contest is August 18, 2024. USACE employees and members of their immediate household are not eligible to win, but you can help someone creating a video as long as you are not listed as a team member on the entry and no government funds are used to produce the video.
