Preface

The Mississippi Valley Division (MVD), acting through our six districts (St. Paul, Rock Island, St. Louis, Memphis, Vicksburg and New Orleans), is committed to providing public recreational opportunities while applying sound environmental operating principles to lands, waters, and other resources entrusted to our stewardship.

This program management plan (PgMP) provides a cooperative strategy for addressing the critical regional issue of water safety within MVD.

In accordance with ER 5-1-11, U.S. Army Corps of Engineers Business Process, this dynamic PgMP will be reviewed annually to make sure it reflects changes in strategy, funding, or management goals.

- 1.0 Purpose, Background, Strategy, Introduction, and Goals.
- **1.1** <u>Purpose</u>. This PgMP clearly defines water safety program goals that can best be addressed on a regional level. The result will be a regional plan that addresses water safety issues; defines goals, responsibilities, and milestones; addresses critical issues and creates a process for incorporating lessons learned.
- **1.2** Background. The Districts within the Mississippi Valley Division manage over 1.2 million acres of water and 597,000 acres of land. The Division's recreation program has 33 lakes, 39 navigation pools, 288 recreation areas, 14 visitor centers, 273 boat ramps, 6,030 camp sites, and 6,074 miles of lake shoreline. Between 1997 and 2007 there were 152 public fatalities at MVD recreation projects. This is an average of 14 fatalities each year for this eleven-year period. MVD currently has one of the lowest numbers of fatalities per visit of all Divisions at 0.50 fatalities per 1,000,000 visitor days. The national average is 0.80. While this is encouraging, continued assessment of ways to reduce fatalities is necessary in order to go from "good to great."
- **1.3 Way Ahead (Strategy).** CEMVD-DC appoint a MVD Water Safety Product Delivery Team (WS-PDT) to develop a regional approach to water safety initiatives, and to support and enhance district and field project water safety programs by:
 - Promoting regional water safety education with a consistent message.
 - Creating new materials and methods to promote regional water safety.
 - Practicing open communication and sharing lessons learned for all MVD employees who work with the water safety program.
 - Evaluating regional water safety trends, statistics, and incidents.
 - Developing a PgMP for the MVD water safety program and reviewing it annually.
 - Consolidating the acquisition and distribution of water safety products within MVD.
 - Encouraging Corps partnerships with appropriate agencies and businesses throughout the Mississippi Valley Division.
 - Continuing to actively engage thru MVD PDT member representation in the USACE directive to evaluate mandatory personal flotation devices (PFDs).
- **1.4** <u>Introduction</u>. CEMVD Operations, Natural Resources, and Safety representatives initially met via teleconference in April 2008. The team developed the Division's initial draft of the Water Safety PgMP. They identified goals to incorporate into a regional strategic plan. Short and long-range goals were identified and incorporated into the plan. It was agreed that participants will solicit input from field offices, share information

and obtain feedback. The District Chiefs of Operations will be routinely briefed to ensure district support.

- 2.0 Organizational Responsibilities.
- **2.1** Mississippi Valley Division. MVD will provide oversight of the WS-PDT.
- **2.2** <u>MVD Districts.</u> District Commanders are responsible for managing recreational safety programs within their district boundaries. Each district, acting through the operations division, is responsible for actively supporting initiatives and implementing results. Districts will assign personnel to the WS-PDT and ensure that products meet customer requirements and needs.
- **2.3. PDT Composition.** The MVD recreation program manager will be a permanent member. The MVD-PD-KM Chief and the MVD-SO will be co-champions. Each district's operations division will provide one permanent representative (District's water safety POC) and one rotating member (preferably from a field project) to serve as a field advisory member. In addition, two district safety offices and two district public affairs offices will provide a representative. The MVD representative on the HQUSACE Water Safety Product Delivery Team will be a member for the length of appointment to the WS-PDT.
- **2.4 PDT Meetings**. The WS-PDT will meet as the need arises and will conduct routine teleconferences or videoconferences to review progress and to recommend revisions to this PgMP. A teleconference will be conducted following the major camping holidays of Memorial Day, July 4, and Labor Day to discuss trend data as prepared per PgMP goal. A teleconference will be held following each water related recreation visitor fatality to discuss lessons learned per PgMP goal. Meetings as needed will rotate among districts and will be held at field projects. Project staff at the host location will be invited to participate in the meeting to provide input and field level perspective while developing Division water safety initiatives and goals.
- **2.5 PDT Expenses**. All expenses, salary, travel and per diem will be the responsibility of the employee's organization.
