

W.P. Franklin Visitor Center - Okeechobee Waterway

On January 8th, 2025, a group of 20 students from Riverdale High School visited the W.P. Franklin South Recreation Area and Lock as part of a STEM-focused career exploration program. This immersive field trip provided students with an opportunity to learn about careers in environmental science and engineering through real-world examples and hands-on experiences. Students listened to presentations by Lee Martin, a USACE biologist, and Megan Parsons, a USACE park ranger. After, Lock operator, Jason Pritt, led the students on a tour of the W.P. Franklin Lock, offering a behind-the-scenes look at its operations. Students learned about the lock's role in navigation, its manatee protection systems, and the importance of water safety.



On Saturday, February 1st, 2025, Ranger Megan Parsons and USACE volunteer Cindy Krouse represented the U.S. Army Corps of Engineers at the Cape Coral Waterways Science Festival, a community event focused on environmental education, water resources, and conservation. Four of our high school service-learning students assisted in staffing our booth, engaging with attendees, and distributing water safety informational materials and giveaways. Throughout the event, we educated the public about the Okeechobee Waterway's ecological and recreational significance, and provided resources on water and boating safety, making approximately 500 contacts.



On Saturday, March 15th, 2025, Park Rangers Megan Parsons, Jorge Leyro-Montalvo, and Robert Hill, along with USACE volunteers, participated in the 2025 Clewiston Sugar Festival. This event is the largest winter outreach effort for the rangers, and this year, they engaged with approximately 1,100 visitors. Using their interpretive trailer, rangers and volunteers educated attendees about the Okeechobee Waterway and the Corps' missions. They also promoted water safety by distributing informational brochures and interacting with the public, including photo opportunities with "Bobber the Water Safety Dog."



Carters Lake

On March 18, Dalton's Chick-fil-A hosted a special event called the Stuffed Animal Campout Story Time. During this event, Ranger Spence and McKittrick led a discussion where they shared tips on how to stay safe while camping and how to be mindful when around water. The story time provided an opportunity for kids to learn important safety tips for being at a campsite, such as fire safety. Additionally, Ranger Spence and McKittrick emphasized the importance of water safety, teaching everyone how to stay safe near lakes, rivers, or pools, and the most important thing to wear around water: life jackets!









West Point Lake

Park Ranger Rusty Newton participated in Read Across America Week by reading to Eastside Elementary 2nd grade classes and Huguley Elementary School's kindergarten classes on March 07, 2025. While participating in the activities he made 85 water safety contacts by discussing safe habits around water and reading "Water Watcher: The importance of Wearing a Life Jacket." He also enjoyed reading "Green Eggs and Ham" to the students in honor of Dr. Seuss.





On March 18, 2025, Park Ranger Rusty Newton and Park Ranger Chris Brewer participated in Fairfax Elementary School's Career Day. Both Rangers spoke with each class from Pre-K to 5th grade, over 700 students, about the many hats park rangers wear, the importance of environmental stewardship, natural resource management, the Corps' mission, and water safety. The rangers explained the need for park rangers to protect and preserve our natural resources for future generations to enjoy. The rangers closed out their talks with each class with a water safety message expressing the need for each person to wear their life jackets when in and on the lake.



Walter F. George Reservoir

During the months of January-March, a total of 246 water safety contacts were made through the efforts of Park Attendant Contractors and Volunteers at Walter F. George Reservoir. Often we overlook efforts made by contractors and volunteers that ensure visitors to our lands and waters are safe. They are trained in "reach, throw, row, don't go," offer PFDs to boaters and swimmers from our loaner stations, and engage in general safety with campers/visitors as well. They are a cornerstone to the success of our water safety mission!

On Friday March 21st, Park Rangers Makayla Barlow and Hannah Sue Hulpke were invited to Greenbrier High School by Mrs. Chassidy Gerlach to present to her three environmental science classes that recently covered natural resource energy sources. Makayla and Hannah Sue covered the history, mission, and local importance of the dam and its major benefits. At the end of the program, Rangers Barlow and Hulpke spoke about the importance of water safety, especially the students who were reaching the most at-risk age group. Rangers highlighted some of the risks that may take place around the water and spoke about real life experiences. The rangers wanted to express, how despite being young and capable of swimming, they are still at risk. 83 quality water safety contacts made.

On Saturday March 14th Park Ranger Makayla Barlow caught four adults wearing their lifejackets at Amity Boat Ramp. This resulted in 10 quality water safety contacts between the participants' guests and curious bystanders. Makayla highlighted the importance of wearing lifejackets and how much rangers appreciate the efforts of those adults that choose to be safe and teach those around them that wearing a lifejacket is the number one safety device when on or near the water.

John H. Kerr Dam & Reservoir

In February of 2025 in partnership with staff from W. Kerr Scott Reservoir, Natural Resource Specialist Alec Mitchell and Park Ranger Brandy Holt attended the Central Carolina Boat Show & Fishing Expo. They talked to nearly 2,000 attendees about water safety, natural resource management, and the Corps mission. The employees had a great time interacting with so many people and creating a positive memory for many young children that visited the booth.

On March 12th Ranger Emily Jones facilitated a program at the Clarksville (VA) Public Library for 17 participants about the water cycle and how important understanding the water cycle is when considering water management at US Army Corps of Engineers lake projects. Participants learned about the water cycle and played a game where they pretend to be water molecules moving through the water cycle. A water safety message was given as well at this program.

On Saturday, March 29th Rangers Elaine Wittry and Emily Jones, Carmen Boyette (Wilmington District Natural Resource Management Section staff), and Stewart Gilmore (Wilmington District Natural Resources Lakes Branch Chief) spoke with over 200 participants at the 37th NC Science and Engineering Fair hosted at NC State University. The students, teachers, and parents learned about how hydropower is created and how to engineer a life jacket. A water safety message was given to every participant.
