#### NRM Assessment/OMBIL Review - Allison

- Walk through screens with team
- o Data status
- Issues/changes for Ginny- Heather will send request
  - Add a column for the number of partners (instead of in the same cell)
  - Have description and address separated
  - Can header be fixed so they can be seen as you scroll through the page (is this even possible in oracle?)
  - Add an "undo" on terminate function in case someone hits it on accident
  - When spreadsheet reports are pulled, can we have the partnership type in a separate column
  - When we do Step 2 and enter all of our data by each line, do we have to hit "update" for every line? Is there a reason there's a button for each partnership, or can we click "update" once for the entire page? Or is there a way we can do a notification that says "you have unsaved changes?" Just seek clarification on why it is set up this way, or if an "update all" would be more useful.
  - Follow up: what's the point of the "submit" button if we have to "update" every row? It looks like you can even click "submit" before all the data is entered, giving a false 100%
  - Print Report button from NRM assessment (or "save to Excel spreadsheet")
  - How can PAC team members get access to review data for our division/nation? Or at least Heather/Allison?
- Data Review Heather will have Ginny pull spreadsheets. Module closes at the end of Dec. We'd like 2 weeks (mid Jan) for review.

 Side convo: Reece Nelson in Omaha is great with EDW. Can maybe help us figure out how to pull NRM (esp Partnerships) data out of EDW, understand how to edit and how to use it well for our purposes.

    - Building partnerships capacity have everyone make a list of partners that they think they have at the project
    - Gateway exercise no changes needed
    - Contributions
      - Volunteer scenario type thing... "organization X wants to donate X, can we accept?" do it like the volunteer cards. 5 or 6 yes or no scenarios
      - Action item: Each person on the team come up with at least 1
        acceptable and 1 unacceptable contribution scenario due by
        Jan 8 phone call
      - Remove test questions slides? in place of the cards activity
      - Create a pitch (ex: national public lands day) pitch your partnership exercise – how to sell without soliciting. Allison will take the lead
    - MOU/MOA which is which → students go through the list.
      - Find an example of a MOU and an MOA with the same/similar agency and show how they may be different. Scott will spearhead this task
    - Cooperative Mgmt no exercise? General open conversation about ideas for opportunities... and thoughts as it may apply to their lake.
    - Non-Profit and For Profit culture
      - Exercises talk to a neighbor and make a pitch?
    - Corps Foundation no exercise
    - Cooperating Associations no exercise?
    - Grants lots of applications would require lots of printing. Youtube video showing successes?
      - Possibly provide example applications for RFHP, FPS, NEEF grants so they can see what they look like (maybe a resource sheet that points to examples on the gateway)

- Volunteer Program exercise on volunteer management. Only use 5 or 6 scenarios. Just like 5 minutes. Miriam will send these out. Exercise consists of someone handing our scenarios while leader explains. Students talk about how they'd handle the scenario amongst their team. After the few minutes are over, each group explains their scenario, then instructor asks if the rest of the class agrees or disagrees with how it was handled.
- Military no exercises needed? Video from west point? Supply drop video at Ouachita?
- Water Safety hit on various slides throughout. Did all the questions and facilitate conversation. Keep it like it is for next class and make modifications after that. Prizes for best drawing of someone in a life jacket.
- University video! Everyone's favorite!
- Special Events quick presentations. Don't need to be as lively.
- NRM Assessment Ginny may be able to work a test site for us, but probably not during the NRM-Assessment Open Season. Suggestion that if the instructor has access to it, they can do a live demo and navigate around the site.
